# What is the Restoration Advisory Board (RAB)?

The JB MDL RAB is an advisory body designated to act as a forum for the discussion and exchange of information regarding environmental cleanup progress between JB MDL, the regulatory agencies, and the community.

Lakehurst Naval Air Station formed a Restoration Advisory Board (RAB) in 1994, Fort Dix formed a RAB in 1996, and McGuire Air Force Base formed a RAB in 1999. In 2010, as part of the Base Realignment and Closure (BRAC) process Joint Base McGuire-Dix-Lakehurst (JB MDL) merged the three RABs from each former installation into one RAB for the joint base.

The JB MDL RAB is intended to bring together community members who reflect the diverse interests within the local community. The JB MDL RAB is not a decision making body.

The RAB consists of primarily community members, but also includes representatives from the Air Force, the



Environmental Protection Agency (EPA), the New Jersey Department of Environmental Protection (NJDEP) and the Pinelands Commission. The structuring of the RAB allows a two-way flow of information and concerns between the affected community, the regulatory agencies and the Air Force.

All RAB meetings are open to the public. JB MDL provides administrative support, and additional technical assistance is available to RAB members.

#### How to Become a RAB Member:

Community members interested in finding out more about the RAB are encouraged to attend the quarterly JB MDL RAB meetings. At the meetings, you will hear updates on the status of base clean-up activities and selected presentations on current projects.

The quarterly RAB meetings are usually held during the third week in August, November, February and May from 6:30 to 8:00 PM at the New Hanover Township Senior Center. An advertisement is posted in the Asbury Park Press, the Burlington County Times, and the Pine Barrens Tribune the Sunday prior to the RAB.
